The Notice outlines the detailed steps that each Member and Vendor needs to follow during 'Mock Trading' session in order to check their connectivity access using trading tools such as EOS-Trader, EOS-Clear, PORTS (FIX), EMAPI (MBL / POBE), SSL & IPSEC VPN, Drop copy and Member FTP Server over their respective existing mode of network connectivity.

The network infrastructure upgradation task will be executed on **Saturday, May 12, 2018** between 03:00 Hrs to 8:00 Hrs (Dubai time).

Members and Vendors are kindly requested to take a note that there will be no change required at their end to participate in 'Mock Trading' session at network level.

Procedures to be followed during the 'Mock Trading' Session

LOGIN PROCEDURE

- There is no change in the login procedure. Members can use their existing Live User ID and corresponding passwords to login for the Mock Trading using the existing version of EOS-Trader/ EOS-Clear/ EMAPI and FIX.

POST TRADING ACTIVITIES

- Exchange will generate back office reports after the 'Mock Trading' which shall be available in the Live FTP Server (under Mock folder). Members may download these reports from the FTP Server for verification purposes after 15:00 Hours. To reiterate, the trades executed in 'Mock Trading' sessions will not involve any financial obligation for pay-in and pay-out.

REVERT TO PRODUCTION SETUP (EXISTING LIVE)

- No additional activity is required for the EOS production access (Live). Members must start the existing production applications on the next trading day as usual.
