Subject: Amendments to listing of DWTI, DWTIM and DBRC contracts

Pursuant to DGCX By-laws and DCCC clearing rules, Members are requested to note that the Exchange shall make the following amendments to listing of WTI Light Sweet Crude Oil Futures (DWTI), WTI Mini Light Sweet Crude Oil Futures (DWTIM) and Brent Crude Oil Futures (DBRC) contracts from Close of Business on **July 19, 2024**.

1. Reduce the number of outright contracts in DWTI from 28 to 3 and change the spread creation rule of these contracts to reflect only M1-M2.
2. Reduce the number of outright contracts in DWTIM from 12 to 3.
3. Reduce the number of outright contracts in DBRC from 18 to 3 and change the spread creation rule of these contracts to reflect only M1-M2.

Members may please note that all Open Positions existing in the Futures Contracts that will be de-listed at Close on **July 19, 2024**, will be settled in cash at a Settlement Price determined in accordance with the rules and procedures of the Exchange.

Broker Members trading on behalf of Clients are to ensure that they advise their clients accordingly.
